A discussion from Council Members addressing Mr. Jeremiah Bradley, Construction Engineer with SCDOT in Chester. **CCTC Member Jordan** asked why so much and basically Mr. Bradley said someone in Columbia made a mistake that they used figures that didn't work. **CCTC Chairman Roddey** suggested CCTC Members deny this request, especially since SCDOT had not gone out for bids on these roads. **CCTC Member Guy** asked Mr. Bradley what would they do if they were denied the monies and Mr. Bradley said they would go as far as they could go with what they had (which is in excess of \$295,000 already allotted). **CCTC Member Lucas made the**Motion to deny the request of SCDOT for an additional \$146,415.22, 2nd by CCTC Member Branham, CCTC vote was unanimous.
