- A. Summons and Petition *OR Application* for Appointment of Conservator for minor (Form #542GC---assets to be received by a minor in the amount of \$15,000.00 or more).
- B. Copy of Long Form Birth Certificate and Social Security Card for Minor.
- C. Applicant's Credit Report.
- D. Applicant's Criminal Background Check (which is a SLED check for S.C residents or a check in the state of residence for out-of-state residents)
- D. If filing a formal action the filing fee is \$150.00; however, if filing an application, the filing fee is \$25.00 made payable to the Chester County Probate Court.
