2. Sludge

**David Cole** came before Council to talk about the sludge issues in South Carolina. Mr. Cole asked that Council consider passing an Ordinance to protect the citizens Of Chester County or figure out another way to protect the citizens. He stated that Chester County was a "hot bed for cancer" and that it couldn't be proved that this Sludge was the cause of cancer in Chester County but that it was the number one dumping ground for this material. DHEC was asked to look into this and DHEC responded that no one was doing anything wrong. Mr. Cole suggested instead of allowing this Class B material to be used to bump it to Class A. **Council Member Jordan** asked how would this be done and Mr. Cole said pasteurization. **Vice Chairman Lucas** asked if DHEC was monitoring this "sludge" and Mr. Cole stated only if there was a problem. **Vice Chairman Lucas** asked Mr. Cole what was his major complaint, odor, contaminants or what and Mr. Cole responded those plus viruses, bacteria and everything else that is associated with the sludge. **Council Member Holcombe** stated that he had a lot of farmers in is District and have never had any complaints and **Council Member Guy** said she recently drove by a farm and smelled nothing. Mr. Cole then said he was just trying to say there was a better way to use this material and it wasn't just Chester County it was all over and that using the material was putting lives at risk. **Council Member Holcombe** then said if DHEC approved he did not see what County Council could do. **Council Member Branham** then said they had had a meeting on Wednesday with Mr. Cole and this issue had been discussed. **Chairman Roddey** suggested a Motion to take this as information only. **Council Member Holcombe then made the Motion to take this as information only. 2<sup>nd</sup> by Council Member Branham**, **Council Vote was unanimous**.

#### VII. Old Business

#### 1. Eureka Mill

**Arthur Gaston, Attorney** came before Council stated he represented Larry Ramsey and Pamela Womak (the lady that put up the \$50,000 bond). Mr. Gaston started out by talking about the Springstein Mill, which after a considerable amount of time discussing how much the County paid (\$500,000) to clean it up was told by **Chairman Roddey** that the Springstein was not cleaned up by the County because it was in the City and all the County did was some "inkind" labor, the City had obtained a Grant for this cleanup, Mr. Gaston then passed out pictures of the site that Mr. Ramsey had purchased and, in his opinion, as agreed in the MOU, cleaned up in a three phase operation. He asked the County to return the money less \$6,000 in fines from DHEC. **Chairman Roddey** then responded to Mr. Gaston that Council would be discussing this same subject in an Executive Session later in the meeting.
