<u>Vice Chairman Lucas made the Motion to approve the Chester County Council</u>

<u>Meeting Minutes of November 21, 2011, 2nd by Council Member Holcombe. Council vote was unanimous.</u>

Chairman Roddey stated that two last minute items needed to be added to the agenda. The first item was an amended Ordinance that added an additional \$150,000 from the USDA to the Richburg Fire Protection District. Council Member Oliphant made the Motion to add the Ordinance to the agenda, 2nd by Council Member Jordan, Council vote was unanimous.

Chairman Roddey then said the second item was an Economic Development matter on Project 1031 that Council would need to go into Executive Session to discuss. Council Member Guy made the Motion to add Executive Session to the Agenda, 2nd by Vice Chairman Lucas, Council vote was unanimous.

IV. Citizens Comments

Mrs. Gloria Kellerhals came before Council to thank the County for their help in getting downtown Chester ready for the festival. In particular, she thanked Robert Hall for going above and beyond the call of duty, working late, helping with the decorations, lighting, etc.

Mr. Chris Winters came before Council to introduce the new Librarian, Lou Anne James to Council and members of the audience. Mr. Winters, Chairman of the Library Board, thanked everyone that attended the Meet & Greet held last week to introduce Ms. James.

Ms. James told Council that she was very happy to be in Chester and looked forward to working with and getting to know everyone.

Added to the Agenda:

1st Reading of an Ordinance Authorizing the Issuance and Sale of a Not Exceeding \$150,000 Fire Protection District Improvement Revenue Bond of Chester County, South Carolina, for the Purpose of Defraying the Cost of Improvements to the Richburg Fire Protection District; Prescribing the Form and Details of the Bond; Providing for the Increase in Rates and Charges for Services Furnished by the District to Provide Sufficient Revenues from the Operation of the System for the Payment of the Principal of and Interest on the Bond from the Revenues; Creating and Establishing Certain Funds and Accounts; and Making other Covenants and Agreements in Connection with the Foregoing; Authorizing the Aggregation of the Bond Authorized by this Ordinance and the Bond as Authorized in Ordinance No. 05-02-11; and Other Related Matters.

Council Member Jordan made the Motion to approve 1st Reading of the above Ordinance, 2nd by Council Member Guy, Council vote was unanimous.
