1. Chester County Council Meeting Minutes of June 6, 2011

**Vice Chairman Lucas made the Motion to approve the Chester County Council Meeting Minutes of June 6, 2011, 2<sup>nd</sup> by Council Member Guy, Council vote was unanimous.**

**IV. Citizens Comments**

**Mr. Mike Enoch, President of Chester County Natural Gas Authority** came before Council to let them know the large green pipes that had been seen throughout the County were the results of the joint effort with Lancaster and York County to supply natural gas. Council had passed a Resolution in June, 2010 in support of the Patriots Energy Group. Mr. Enoch said that this would result in a substantial savings and an unlimited capacity of Natural Gas in Chester County.

1. Report on bids taken for Research & Development Park

**Chairman Roddey** stated that the bid process was back on the R&D Park and the low bid was Davis Grading, Inc. of Shelby, NC in the amount of \$302,400.58. **Chairman Roddey** recommended Council take this as information only and that Council vote on the bid

award at the CCTC meeting on July 5.

**Council Member Branham made the Motion to accept this as information only and be on the next CCTC agenda, 2<sup>nd</sup> by Vice Chairman Lucas, Council vote was unanimous.**

### **1. Legislative Update**

**Mr. Robert Croom/Association of Counties** gave Council a Legislative update.

He said some of the items that were being considered now were: Budget, ATI Bill, Millage Rate Limitation, Voter ID Bill, Illegal Immigration Bill and the Copper Thief Bill.

Mr. Croom said anytime Council had any questions whatsoever to please give him a call.

### **2. Information on Fire Dept. Smoke Trailer**

**Beth Huey/Fire Coordinator** was asked to bring out the new Smoke/Fire Trailer that had been purchased through Grant monies. She said a committee had been formed to decide what would be put in the trailer and they wanted "eye catching" graphics painted on the outside. **Council Member Oliphant** asked what was the value of the Grant and Mrs. Huey replied \$75,000. **Council Member Holcombe** also said it was a 100% Grant. The trailer was most impressive and **Mrs. Huey** said it was for use throughout the County.
