IV. Citizen's Comments

Mr. Rick Anderson came before Council to congratulate **Chairman Roddey** and other county officials for the success of bringing new industries into Chester County. (Mr. Anderson's comments are included with the minutes.

Mrs. Roxanne James came before Council to ask if Highway 56 was widened to please consider the Historic home very near the road that was built in 1820. **Chairman Roddey** replied to **Mrs. James** that Highway 56 was a State road and that she might contact SCDOT should the road be widened in the future.

Mr. Herbert Morrow came before Council to ask that the Wagon Wheel Program for senior citizens not be discontinued. **Chairman Roddey** asked where it came from that it was not a County program, Mr. Morrow said he didn't know but it also fed kids in summer school. **County Attorney Winters** then said it was a function of the YMCA and not through the County.

Mrs. Elizabeth Claytor came before Council to announce the 49 mile yard sale from Whitmire to Richburg was this weekend and although she knew there was no funding, inquired how she might next year obtain funding for this project. **Chairman Roddey** told **Mrs. Claytor** that may be something she could pursue through A-tax. **Mrs. Claytor** thanked Council for their time and invited everyone to the event this weekend.

10. COPS Grant

Major Randy Marsh stated this was a 75%/25% Grant that would expire in October. Currently two officers are under this Grant and their duties included; coordinating funeral escorts, assisting the Dept. of Juvenile Justice, and assisting Senior Services with the delivery of food, assisting school resource officers, part of the crime watch programs and checking for sex offenders. **Chairman Roddey** suggested to Council that this be taken as information until after the June 11th Council Budget work session, but <u>Council Member</u> <u>Guy made a Motion to allow the Sheriff's Dept. to apply for the COPS Grant, 2nd by</u> <u>Council Member Holcombe.</u> Council Member Jordan then stated this would cost over \$172,000 over a 4 year period and Council Member Oliphant asked if this was in the Sheriff's budget. Chairman Roddey stated only for this year or until June 30th. <u>Council then voted and the vote was 3 to 2 in favor of the Sheriff's Dept. applying for the COPS Grant with Vice Chairman Branham and Council Member Jordan voting against.</u>

11. Status of Elections & Passport Services

Earl Moore/Elections Director relayed to Council that everything was ready for the upcoming election. He was a little concerned about the machines because they were old but felt the election would run smooth. He did state that if anyone was running as a petition candidate they would need 1,052 signatures and the petition would need to be certified before their name was on the ballot. The only other matter was that Ward 3 had been split and some citizens would vote at this building but notifications were sent out in November and December. Also, precincts in Great Falls and Lando had been combined. Lastly, passports can now be applied for at the Voters Registration office in Chester.

Council Member Jordan made a Motion to appoint Ms. Roseann Hicklin to the Library Board, 2nd by Council Member Guy, Council vote was unanimous.
