V. Ordinances & Resolutions

 Inducement Resolution Providing for a Fee in Lieu of Tax Agreement Between Chester County and Project Duck

Vice Chairman Branham made a Motion to approve an Inducement Resolution
Providing for a Fee in Lieu of Tax Agreement Between Chester County and
Project Duck, 2nd by Council Member Lucas, council vote was unanimous.

3. 1st Reading An Ordinance (In Title Only) Authorizing the Execution and Delivery of a Fee in Lieu of Ad Valorem Taxes Agreement to Provide for a Fee in Lieu of Tax Incentive and an Infrastructure Credit to Project Duck; the Inclusion of the Project Duck Site into a Multi-County Business Park; and other matters related thereto

Council Member Lucas made a Motion to approve 1st Reading of an Ordinance (in Title Only) authorizing the Execution and Delivery of a Fee in Lieu of Ad Valorem Taxes Agreement to Provide for a Fee in Lieu of Tax Incentive and an Infrastructure Credit to Project Duck; the Inclusion of the Project Duck Site into a Multi-county Business Park; and other matters related thereto, 2nd by Vice Chairman Branham, Council vote was unanimous.

VI. Old Business

1. Report on Mandate from Sheriff's Dept.

Britt Lineberger told Council Members he and the IT Director were in the process of doing research on the relating to the mandate from the Sheriff's Dept. and would have a report at the next County Council Meeting. County Attorney Winters asked Mr. McMurray did he know about this mandate prior to September and he replied "he did not". Vice Chairman Branham asked how long after Council received the report could they get started and Mr. McMurrary responded "pretty quick except for purchasing some equipment. Council Member Jordan asked would the Criminal Justice Dept. work with you if you are showing progress and Mr. Lineberger replied "on most items". Chairman Roddey asked for a Motion to take this as information only. Council Member Guy made the Motion to accept this as information only, 2nd by Council Member Holcombe, Council vote was unanimous.

VII. New Business

1. Update on USCL

Dr. Walt Collins from The University of South Carolina at Lancaster came to give an update on the happenings at USCL. **Dr. Collins** said presently there were 1,725 students presently enrolled at USCL and 138 were from Chester that included 41 students taking duel credits. **Dr. Collins** said they were excited to serve students in Chester County as well as the surrounding counties. One of the highlights this year is that Founders Hall has been constructed and it includes classroom space, faculty space, etc. it is approximately 40,000 sq. ft. USCL is in the process of constructing a nursing simulation lab which should be ready after next spring. The Carolina's Promise Campaign will end in June with USCL working toward a \$10.M goal. It is a 4 year degree program so students don't have to travel. **Chairman Roddey** thanked **Dr. Collins** for this hard work and stated they did a wonderful job and Council appreciated the update.

2. Airport Grant with match

Tommy Darby/Finance Department came before Council to request approval of a Grant for The Chester Regional Airport in the amount of \$709,673.00 with a match of \$34,484 from the County.

Council Member Oliphant made a Motion to approve the grant for the Chester Regional Airport in the amount of \$709,673 with a \$34,484 match from the County, 2nd by Vice Chairman Branham,

Discussion: Council Member Oliphant asked if the Airport Commission bid this project out through Chester County. Tommy Darby stated no and Chairman Roddey stated they used a different engineering procedure. Council Member Oliphant said he would like to see their bid process and Mr. Darby said he would get that information. Council Member Oliphant then asked how many planes could be stored in the new hanger and Mr. Darby said he did not know but would gladly have someone from the Airport Commission at the next meeting to answer Council's questions. Council then voted and the vote was unanimous.

3. David Minor Complex/Republic Ball Field Grant with match

Tommy Darby/Finance Director came before Council to request approval of a Grant in the amount of \$30,000 with a \$6,000 match from the County for the Republic Ball Field

Council Member Jordan made a Motion to approve a Grant in the amount of \$30,000 with a \$6,000 match for the Republic Ball Field, 2nd by Council Member Guy, Council vote was 5 to 0 with Council Member Lucas recusing himself.

VIII. Executive Session

Chairman Roddey stated that Council would need to go into Executive Session to discuss:

Council Member Lucas made a Motion to go into Executive Session, 2nd by Council Member Guy, Council vote was unanimous. (Time was 6:25pm)

Chairman Roddey stated a legal matter was discussed and Council Member Jordan made a Motion to instruct legal counsel to pursue a favorable consent order on Council's behalf with regard to current litigation, 2nd by Vice Chairman Branham, Council vote was unanimous.
