funded so much more than other entities. Ms. Addison explained that the museums and arts council were open year round whereas other events were annually. **Council Member Lucas** stated it seemed unfair to the other communities and Ms. Addison said other communities did not apply, only the ones listed and everyone that applied with the exception of Olde English District received funding. After much further discussion, **Chairman Roddey called for the question. Mr. Rodney Brown and Nick Emerson came before Council to ask if there was anything Council could do to get something started in Chester for the youth. Chairman Roddey told Mr. Brown and Mr. Emerson that the budget had already been set for this year, but for them to form a committee and he would appoint a couple of council members to get started on discussions for recreation in Chester County. Chairman Roddey then said the county already provides more than \$160,000 for recreation but will do whatever we can to help out.

4. Clemson Extension
