Chairman Roddey opened the Public Hearing on:

1. An Ordinance TO LEVY AND IMPOSE A ONE PER CENT SALES AND USE TAX, SUBJECT TO A REFERENDUM IN CHESTER COUNTY PURSUANT TO THE CAPITAL PROJECT

SALES TAX ACT, SOUTH CODE ANNOTATED SECTION 4-10-300, ET SEQ.; TO DEFINE THE SPECIFIC PURPOSES AND DESIGNATE THE PROJECTS FOR WHICH THE PROCEEDS OF THE TAX MAY BE USED: TO PROVIDE THE MAXIMUM TIME FOR THE IMPOSITION AND COLLECTION OF THE TAX AND THE MAXIMUM AMOUNT OF NET PROCEEDS TO BE RAISED BY THE TAX: TO PROVIDE FOR A **COUNTY-WIDE** REFERENDUM **PRESCRIBE** THE CONTENTS OF THE BALLOT QUESTION IN THE REFERENDUM; TO PROVIDE CONDITIONS PRECEDENT TO THE IMPOSITION OF THE TAX **AND** CONDITIONS OR RESTRICTIONS ON THE USE OF THE TAX REVENUE; TO ESTABLISH THE PRIORITY IN WHICH THE NET PROCEEDS OF THE TAX ARE TO FOR THE **EXPENDED PURPOSES** PROJECTS STATED; TO PROVIDE FOR THE CONDUCT OF THE REFERENDUM BY THE CHESTER COUNTY VOTER REGISTRATION AND ELECTION COMMISSION; TO PROVIDE FOR THE PAYMENT OF THE TAX; TO PROVIDE FOR THE ISSUANCE OF BONDS, IN ONE OR MORE SERIES, TAX-EXEMPT OR TAXABLE, IN AN AMOUNT NOT TO EXCEED THE **AGGREGATE** OF \$15,000,000; AUTHORIZING THE COUNTY SUPERVISOR TO PRESCRIBE THE FORM AND DETAILS OF THE BONDS: PROVIDING FOR THE PAYMENT OF THE BONDS AND PLEDGE OF REVENUES RELATED TO THE BONDS; PROVIDING OTHERWISE FOR THE DISPOSITION OF THE PROCEEDS OF THE BONDS; PROVIDING FOR BORROWING IN ANTICIPATION OF THE ISSUANCE OF THE BONDS; PROVIDING FOR THE DISPOSITION OF PROPERTY RELATED TO THE BONDS; AND OTHER RELATED MATTERS.

Mr. Shane Stuart came before Council to say that he supported the One Cent Sales Tax because it was a fair and equitable solution and would hope the voters would support it. He also stated that he believed in recreation for all areas of the county to keep the young people's attending and hoped recreation would be a part of the funding. Also,

he would hope that there would be something to support the local area businesses, maybe some way to give back to them by setting up some sort of fund and the third item was he hoped the County could roll back taxes.

 Mr.Mike Enoch presented the recommendations from the Sales Tax Commission (included in minutes). Mr. Enoch stated the total aggregate amount was \$14.5M

Mr. Michael Kozlarek with Parker Poe (Bond Attorney) came before Council and stated that the actual amount in the Resolution was \$13,5M. At this time, Vice Chairman Branham made a Motion to amend the Resolution/Ordinance to state the aggregate amount should reflect \$13.5M, 2nd by Council Member Jordan, Council vote was unanimous.

Council Member Jordan then made a Motion to accept the recommendations of the One Cent Sales Tax Commission in the amount of \$13.5M aggregate, 2nd by Vice Chairman Branham, Council vote was unanimous.
