Chairman Roddey opened the Public Hearing on:

1. A public hearing on the question of Chester County, South Carolina ("County") establishing, pursuant to Chapter 19, Title 4, Code of Laws of South Carolina, 1976, as amended, two fire protection districts in the County to be known as the "Lewis Fire Protection District" and the "Fort Lawn Fire Protection District."

There were no speakers, therefore **Chairman Roddey** closed this portion of the Public Hearing and opened the below:

2. A public hearing relating to an Ordinance "Establishing Fire Protection Districts in the County; Providing for the Operation and Maintenance of the Fire Protection Districts; Authorizing the Levy of Ad Valorem Taxes or the Imposition of Rates to Provide for the Fire Protection Services in the District; Defining the Boundaries of the Fire Service Areas in the County; and Other Matters Related Thereto."
