After Pledge of Allegiance & Invocation, **Chairman Roddey** announced that **Council Member Guy** had been there earlier but was ill and went home. <u>Chairman Roddey also said that Council Member Jordan wanted to add</u> <u>Carolina Thread Trail to the agenda and put that in the form of a Motion</u>, 2<sup>nd</sup> by Council Member Branham, Council vote was unanimous.

**County Attorney Winters** stated the only amendment was the inclusion of the word "non resident".

## <u>Vice chairman Lucas made a Motion to approve 3<sup>rd</sup> and final Reading of an Ordinance</u> to Authorize the Imposition of Service Fees for Motor Vehicle Incidents Occurring

Discussion: Vice Chairman Lucas asked if all the fire departments had been notified of this fee and County Attorney Winters replied that it would have been presumptuous to do so before 3<sup>rd</sup> and Final Reading. Vice Chairman Lucas then requested that since this was final reading a letter be sent to all fire departments. <u>Council then voted and the vote was</u> <u>unanimous.</u>

Council Member Branham asked if Council Members should have their appointments at the next meeting and Chairman Roddey replied yes. <u>Council then voted</u> <u>and the vote was unanimous.</u>

Mack Paul, Planning and Zoning Director, came before Council to clear up some concerns regarding Limited Commercial rating from the last meeting. He gave all Council Members a print out of exactly what Limited Commercial entailed. Council Member Jordan asked what the main difference was in General Commercial and Limited Commercial and Mr. Paul replied residential. Council Member Branham thanked Mr. Paul for reviewing this because the County wanted to keep the integrity of York Tech. College in this area. **Council** Member Oliphant asked if Council Member Branham was comfortable with the LC rating. and Council Member Branham said he was. Council Member Oliphant then said maybe

the whole section should be zoned differently. **Council Member Branham** stated that residential is on the left and GC on the right and that we just wanted to keep the entrance as nice as possible. **Mr. Paul** said that the Planning Commission was aware of this. **Council Member Jordan** then asked if this was in keeping with the Comprehensive Plan and **Mr. Paul** replied "not really". **Council Member Jordan then** said he saw in the minutes that Mr. Cabrey had asked about a reverter clause and **Council Member Branham** replied that when the Comprehensive Plan was put together York Tech wasn't there and that the Comprehensive Plan iwas really just a "road map". **Mr. Paul** said his office was keeping up with this and **Council Member Jordan** asked if this was "the best fit" and **Mr. Paul** replied it was. **Council Member Oliphant** asked if some portion from the school to the Winn Dixie was GC and **Mr. Paul** said it was.

### <u>Council Member Branham made a Motion to uphold Planning Commissions</u> <u>Recommendations on Map Amendment #CCMA09-0002, 2<sup>nd</sup> by Council Member</u> Jordan, Council vote was unanimous.

3. Update on new Detention Center/Jail

Frank Williams/Pinnacle Architecture told Council that basically the drawings were finished and under review by the State Jail Inspector. The Fire Marshall has already approved them and when the State Jail Inspector finishes they can be put out for bids and this was a good time for bids to go out. **Councilman Branham** asked if the bids would be back by May 1, 2009 when the penny sales tax went into effect and Mr. Williams replied if the Jail Inspector has finished by the end of February the bids can get out and we could could start in May and he anticipated it would be about a 14 month project. **Councilman** Jordan asked how many phases did he expect it to be done in and Mr. Williams replied about 4 or 5. **Councilman Oliphant** then said the plans were very functional and good looking. Mr. Williams said that Chester County would have a "State of the Art" facility and he believed other Counties would be looking at Chester County once the project was completed. Councilman Jordan asked if inmates would be housed elsewhere during the renovations and Mr. Williams replied they would not. Councilman Oliphant asked if all the old roofing would be taken off and Mr. Williams replied it would. Councilman Oliphant asked Mr. Williams if he anticipated any environmental problems and **Mr. Williams** replied he didn't think so. **Mr. Williams** went on to inform Council that 911 would be moving there also and they would be in a secured area right in the middle. Chairman Roddey asked Mr. Williams to address the Court Room area. Mr. Williams said there would be two court rooms with separate entrances and the Magistrates and Judges would have separate entrances. **Councilman Branham** asked about the visitation area and **Mr. Williams** said there would be a larger lobby and a better visiting area with plenty of room. Councilman Branham asked how much would a new facility cost and Mr. Williams said somewhere around \$70-80 Million Dollars. Councilman Holcombe asked about the sewer system and Mr.

Williams said that would be totally redone. Chairman Roddey thanked Mr. Williams for his time and presentation then called on Margaret and Gary Pope, attorneys that are handing the GO Bond for Chester County. Mrs. Pope said this was First Reading and that they had met with Jack Kindle, County Treasurer to make sure cash flow would be there. She stated they would probably move payments to November and after 3<sup>rd</sup> Reading and Public Hearing they would be able to have the bonds issued by May. Chairman Roddey asked if the money was still out there to borrow and Mrs. Pope replied it was. Vice Chairman Lucas asked if the credit rating would make any difference and Mrs. Pope said that banks won't be that concerned. Councilman Oliphant then said Chester County should have a good credit rating and Mrs. Pope said we did.

4. Update on New County Website

Councilman Oliphant thanked Chairman Roddey for helping to pull this off and said the committee had \$25,000 to work with and would probably give \$5,000 back. Councilman Oliphant said the website went "live" on Thursday (February 12<sup>th</sup>) and that the other website actually went "dead". He went on to thank Susan Cok in the Purchasing Dept. saying she had done a tremendous amount of work for approximately a year on this. The Company that helped get the site up and going was VC 3 out of Columbia but that it was mostly citizen volunteers that pulled this off. He noted that Mrs. Josette Walton had helped with proofreading, Mrs. Tiffney Thomas of the Westminister Group had also helped but most of all Mrs. Gloria Kellerhals had many, many hours invested in this project and asked that she come to the podium. Mrs. Kellerhals encouraged everyone to look at the site and said that anything could be added and that VC 3 was chosen partly because they're in the county/city business of websites and they will keep it going at a very reasonable rate each month. The website is very data intensive and you can find anything you want on it and Councilman Oliphant is the reason it is up and running today. Mrs. Kellerhals said it had a lot of good information. Councilman Oliphant thanked everyone that had made this happen and just wanted to give Council and update.

#### VIII. New Business

 Approval to apply for new fire smoke house for all Chester County Fire Departments Grant (5% Grant Match)

**Chairman Roddey** stated that Mrs. Holcombe or Mr. Murphy could not attend the meeting and that they were asking for approval to apply for a new fire smoke house grant for all Chester County Fire Departments use. <u>Chairman Roddey then made</u> <u>the Motion to allow the application for the Grant, 2<sup>nd</sup> by Councilman Oliphant,</u> <u>Council vote was unanimous</u>.

Change in Organizational Chart (Animal Control to Sheriff's Dept)
Chairman Roddey said that with the new Detention Center/Jail it would encompass

the Animal Control Office and asked that Animal Control come under the Sheriff's Department. He stated there would be training and they would have one Class One Officer and three Class Three Officers and wear uniforms. **Councilman Branham** asked who would be the contact at the Sheriff's Office and **Sheriff Richard Smith** said he would. **Councilman Branham** asked when would this take effect and **Chairman Roddey** replied March 1, 2009. <u>Councilman Oliphant then made the Motion to place the Animal Control</u> <u>Office under the Sheriff's Department, 2<sup>nd</sup> by Vice Chairman Lucas, Council vote was</u> <u>unanimous</u>.

Added to the Agenda: Carolina Thread Trail - Councilman Jordan

**Councilman Jordan** gave Council an update on the Carolina Thread Trail saying it was now at the stage where they were having meetings or open houses for citizens to view and see potential routes. The meetings are: Tuesday, February 17<sup>th</sup>, 5:00-7:00pm at Chester YMCA, Thursday, February 19<sup>th</sup>, 12:00 noon to 2:00pm at the Front Porch Restaurant in Richburg and also on Thursday, February 19<sup>th</sup>, 5:00 – 7:00-m at the Great Falls Presbyterian Church in Great Falls. **Councilman Oliphant** said a news letter had been sent out that the meeting in Great Falls was at the Memorial Building and that probably an e-mail needed to be sent on the location change in Great Falls.

2. Zoning Board of Appeals

<u>Councilman Oliphant made a Motion to re-appoint Ella Spann-Gore to the Zoning</u> <u>Board of Appeals, 2<sup>nd</sup> by Vice Chairman Lucas, Council vote was unanimous.</u>

3. Library Board of Trustees

<u>Councilman Branham made a Motion to re-appoint Wylie McGarity to the Library</u> <u>Board of Trustees, 2<sup>nd</sup> by Council Member Holcombe, Council vote was unanimous.</u> <u>Councilman Oliphant made a Motion to re-appoint Tamra West to the Library Board</u> <u>of Trustees, 2<sup>nd</sup> by Council Member Branham, Council vote was unanimous.</u>

4. Catawba Regional Council of Governments This item was deferred to the next meeting.

**Vice Chairman Lucas** stated the Memorial Building in Great Falls looked really good and the County workers were doing a great job. He was looking forward to having an open

house so that folks can see where their tax dollars go.
