- **1. Call to Order-**Chairman Stuart called the meeting to order.
- 2. Invocation-Councilwoman Guy gave the invocation.

b. <u>1st Reading of CCMA20-08:</u> Daisy Rollings request Tax Map # 159-01-01-044-000 located off Looper Road, Great Falls, SC be rezoned from RG-1 (Multi Family) to R2 (Rural Two). Planning Commission voted 5-0 to approve. <u>Councilman Vaughn motioned to approve, second by Councilman Wilson. Vote 6-0 to approve.</u>

c. Consideration for Funding an Additional Amount for South Chester Grant To Repair Fire Truck. Chairman Stuart, South Chester was awarded \$30,000 for a VSAFE (Volunteer Strategic Assistance Fire Equipment) grant in late 2019. This money will help in the purchase of a replacement tank on one of their older trucks. They were asking for \$54,416.83 the remaining funds from Council to replace the tank. <u>Vice Chairman Branham motioned to approve, second</u> by Councilman Vaughn. Vote 6-0 to approve.

d. Update on the County Revenue Fund.

Councilman Jordan asked Treasurer Tommy Darby to give an update of where the County currently stands. Mr. Darby, the spread sheet shows the differences between 2019 and 2020, for fiscal year 2020 the revenue exceeded the expenditures by \$189,000 which was good. The expenditure total for the year was \$22,367,875 dollars which was good also, better than what he anticipated. By freezing spending and some positions earlier due to the uncertainties of COVID-19 that helped. It was still early in the current year to see how the revenue would look since the County is two months in the new budget year.

e. Update on County Bonding for the New Animal Shelter.

Councilman Oliphant asked County Bonding Attorney Michael Kozlarek for an update. Mr. Kozlarek stated to his understanding there was some additional funds from the 2018 bond to be used not only for the animal shelter but also for other projects. To his understanding Council was to hold special called meetings to discuss if there would be any other projects to use the funds on, doing it that way Council would decide which project to approve. It would be best to go before the Chester Facility Corporation with one approval. County Attorney Winters said she would reach out to them to see when they could meet and bring it back to Council.

f. The Pinckney Road & Eureka Community Project and Derelict Houses in Chester County.

Councilman Oliphant, he wants people to want to live at the Eureka not because they have to. He wants all of Chester to be a beautiful community, he has stated that a lot over the years. The four percent of FILOT money from economic development could be used which is currently around \$204,000 dollars, ear mark money from economic development general fund for \$119,000, the Eureka performance bond money of \$49,000 dollars and the demolition fund of \$86,000 dollars that will be used on houses to be torn down.

Councilman Oliphant, the company that is contracted by the Building & Zoning department RCI can provide an inspector to identify the houses. Letters could be sent out to the owners to comply with the ordinance to abate the problem. He liked hiring RCI better than hiring someone full time since the full-time person would have to be trained and certified to do the job. By hiring RCI it would take some of the politics out of it. The money is in the Building and Zoning budget to hire RCI to start this, if the owner does not comply a ticket must be written to get the problem corrected. If the problem is not corrected the county would step in and tear the structure down and place liens on the property. <u>Councilman Oliphant motioned to allow</u> <u>Building & Zoning Director Mike Levister to contract with RCI to hire a code enforcement officer to abate derelict houses, second by Vice Chairman Branham</u>. Councilman Oliphant, the funding would come from the money in Mr. Levister' s budget to fund it, any additional money would come from items he spoke of at the beginning of the conversation. <u>Vote 6-0 to approve.</u>

g. Update on the Use of County Buildings for Functions and New Renting Policy.

Councilman Oliphant asked to see a spreadsheet in October of last year of who is paying to rent county facilities and who wasn't. A spreadsheet would be better to read and be more proficient and make the supervisor's job easier as well. This would also show the usage of the facilities and show what kind of revenue the County is getting. To his knowledge there are policy's for renting the Chester and Great Falls War Memorial buildings and the Gateway but was not sure if there was one for others. He would like to see how the buildings are being rented. Chairman Stuart, currently there is not a spread sheet, but documents were provided to the Clerk today. Clerk to Council Karen Lee, there was a lot of documents and she was still in the process of sorting and scanning them in. Councilman Wilson, he had asked at the last meeting to have this and was told Council would be provided the information. Councilman Oliphant asked to have it back on the September 21st, Council meeting.

h. Update on Code Enforcement Officer Position in Building & Zoning

Councilman Oliphant, he did not have anything to discuss sense they plan to proceed to hire RCI.

i. Update on the Burnt Meeting House Cemetery

Public Works Director Robert Hall walked the property a few weeks ago, it would take a lot of work to clear the access road and doesn't have the manpower to go in and do the work himself. Councilman Oliphant would like to have the underbrush cleaned out and the road opened and asked if this could be contracted out. Councilman Oliphant asked Mr. Hall and Chairman Stuart to provide estimates to clean up the road and the underbrush and bring that back to Council at the September 21st Council meeting.

j. Update Regarding Property on Dawson Drive

Mr. Hall stated he did not see a benefit to the County by buying this property. Vice Chairman Branham said he would let the owner know.

k. Update on Rodman Sports Complex

Councilman Jordan stated there had been work on field number one and wanted an update. Mr. Hall, the 2014 sales tax project for the baseball and soccer field bids were put out twice and both times they came in over the funds that were available. A few months ago, he and one of his employees went out to move some dirt and possibly get the field built in house instead of putting it out for bid. They still need to go over it and level it out, but they are limited sense they don't have enough employees. He plans to go back and put up a back stop and has explained this to Roxanne James and David Loftin.

Roxanne James would like a legal opinion on the use of the remaining 2014 Capital Project sales tax funds of over \$5 million dollars, how must it be applied to the remaining 2014 CPST projects list that were approved by the voters in the 2014 voter referendum. They would also want legal opinion for South Carolina Code 4-10-340 [a] [b] and [c]. Attorney Winters would provide a legal opinion to Council since Mrs. James was not a client, the money was not allocated to one project. Mrs. James, there are ten that are under budget and with the 5 million a lot of the projects could be completed. Councilman Jordan, the funds are supposed to be used by next year and asked if Attorney Winters would she give council an opinion of what the funds could be used for along with both legal opinions and asked to add this to the first council meeting in October and do a workshop to discuss the projects.

I. Update Regarding how the Cleaning and Sanitization has been done in County Government

Buildings. Mr. Hall, whenever he was contacted about an office being affected by Covid he contacted Interstate Solutions out of Rock Hill. They came in and sanitized every office in the building. Councilman Vaughn asked if this was done in every instance a county employee was known to be infected. Mr. Hall, every time he was contacted it was taken care of. Councilman Vaughn asked if there were any instances where it was not reported. Chairman Stuart there probably had been, but when he is made of aware of it, he contacts the Public Work Director Mr. Hall. Councilman Vaughn sounds like some have fallen through the cracks and he wanted to make sure the county employees felt safe coming to work.

m. Update on the Negotiations between Great Falls and Chester County Regarding the Recreation Agreement.

Councilman Vaughn, to his understanding Great Falls Council had reviewed the 1995 recreation agreement between Great Falls and Chester County and expired September 1st of this month. Chairman Stuart had spoken with the Mayor and it had not been requested by Great Falls. The mayor wanted the same agreement, they have not taken legislative action to make the

recommendation to County Council. Councilman Vaughn, the County spends a lot on Dawson Drive baseball and softball facility along with money spent at the Rodman Complex.

Brenda Fort, Councilman Vaughn's appointee to the Parks and Recreation Commission said she had tried to get the contract up for discussion several times at recreation commission meetings but due to not having a quorum they could not hold the meeting. If the agreement is not renewed this would be a negative impact for recreation in Great Falls. Attorney Winters said there were some wording of the old agreement would need to come out and changed for legal reasons, the attorney for Great Falls would need to clean the new document up also. Mr. Hall said even though the agreement has expired the county continues to cut the grass and do other maintenance on the fields. Councilman Wilson and Oliphant asked for an updated list of properties maintained by the County and all services provided.

8. New Business

a. Permission to Purchase a Fire Truck for West Chester Fire Department with Bond Money. Vice Chairman Branham motioned to approve \$537,000 dollars to purchase a new fire truck, second by Councilman Wilson. Vote 6-0 to approve.

b. Consideration for Funding for Equipment for West Chester Fire Department. Vice Chairman Branham motioned to approve \$26,797.39 from the contingency fund to purchase equipment, second by Councilman Wilson. Vote 6-0 to approve.

c. Local Option Sales Tax

Treasurer Tommy Darby, the County has a local option sales tax that was put in place in 1994, the County uses 100% of the proceeds from the sales tax. This provides a credit against the county tax bills. During the budget process for this year there were concerns of how COVID-19 would impact the revenue stream. It was also discussed the two funds in the local options sales tax, a property tax credit and a portion of the money considered as county revenue, as he stated earlier the county gives back 100 % to the taxpayers. The revenue the county could obtain is given back to the taxpayers. It was discussed if the money could be used to offset any loss from COVID-19 but felt since the program had built in protections it should ease any impact. Right now, he did not see an impact that would be significant, currently he would keep things they the way they are now. This was taken as information.

d. Setting the County Millage for the Upcoming Year-Auditor Donnie Wade Chairman Stuart motioned to adopt the 2020 proposed millage, second by Councilman Wilson. Vote 6-0 to approve.

e. Request to Accept Coronavirus Emergency Supplemental Funding – Sheriff Max Dorsey Chairman Oliphant motioned to approve the funding grant for \$40,509 dollars for LE Center HVAC Disinfection System and deputy PPE, second by Councilman Vaughn. Vote 6-0 to approve.

f. A Proposal to Change the Organizational Chart for The Animal Care & Enforcement Department. -ACE Supervisor Jeanna Laws. <u>Councilman Wilson motioned to change one full</u> time Animal Care Specialist position and create Two Part Time Animal Care Specialist, second by <u>Councilman Oliphant. Vote 6-0 to approve.</u>

g. Discuss Zoom Meetings-Councilman Oliphant.

Councilman Oliphant along with other Councilmembers said they were ready to return to in person meetings. He felt like they are more effective when they are in a room together and go back to conventional meetings. Chairman Stuart, the county government building will open Monday, September 21st and will also be a council meeting. Councilwoman Guy disagreed, the virus was not getting better, it could spread and felt more comfortable staying with the zoom meetings. Attorney Winters said the normal procedures had been suspended and it was strictly up to Council to decide to stay virtual or go back to live meetings. Councilman Wilson, he was sensitive to those issues but felt if employees were going to be asked to work in the building the Council should lead by example and do the same.

IT Director David Schuelke was asked if Councilwoman Guy could meet virtually while the rest of Council would be in council chambers. Mr. Schuelke said he thought he could make it work but may not have it ready for the next council meeting.

9. Boards and Commissions

a. Appointments to the Fort Lawn Fire Protection District-County Council.

After much discussion it was decided to maybe interview each applicant to find out why they would like to be on this board. Then hold a special called meeting for each applicant to attend.

Chairman Stuart, the County has seven or eight candidates for the Economic Development position, the CDA is helping with a hiring committee.

Vice Chairman Branham, all of Council should be promoting the one cents sales tax, some people are concerned it want to get passed. He said to let people know there may be one project they don't like but could be five or six that they do want to get passed. The one cents sales tax helps the County to progress by being able to do things the county can't afford to do. The vote by Council was 6-0 to approve to add it to November's referendum and it would be a great thing for Chester County.

13. Adjourn-Councilman Oliphant motioned to adjourn, second by Councilman Wilson. Vote 6-0 to adjourn.

A RESOLUTION OF CHESTER COUNTY, SOUTH CAROLINA

SUPPLEMENTING RESOLUTION #2018-3, RELATING TO THE INSTALLMENT PURCHASE PLAN OF FINANCE RELATING TO VARIOUS CAPITAL PROJECTS IN THE COUNTY; AND OTHER RELATED MATTERS.

WHEREAS, Chester Facilities Corporation, a South Carolina nonprofit corporation ("Corporation") was previously formed solely for the purpose of supporting the governmental mission and certain activities of Chester County, South Carolina ("County");

WHEREAS, pursuant to Ordinance No. 3-19-12A ("2012 Ordinance"), enacted on March 19, 2012, the County authorized an installment purchase plan of finance for various capital projects in the County;

WHEREAS, pursuant to the 2012 Ordinance, the Corporation issued its \$6,385,000 Installment Purchase Revenue Bonds, Series 2012 ("2012 Bonds"), for the purpose of defraying the costs of constructing, acquiring, equipping, renovating and expanding the 2012 Projects, as defined in the Trust Agreement between the Corporation and Regions Banks, as trustee, dated April 10, 2012 ("Trust Agreement");

WHEREAS, the County enacted Ordinance No. 2018-5 on February 5, 2018 ("2018 Ordinance") to amend the definition of "Project" under the 2012 Ordinance;

WHEREAS, the County adopted Resolution #2018-3 on March 19, 2018 ("2018 Resolution") confirming the amendment to the installment purchase plan of finance and consenting to the Corporation's issuance of the Corporation's \$19,255,000 Installment Purchase Revenue Bonds (Chester County 2018 Projects) Series 2018 ("2018 Bonds") to refund the 2012 Bonds and to provide for funds sufficient (a) to make improvements to the County's Gateway Conference Center, (b) provide funds to acquire or construct and equip a County hazardous materials building, and (c) provide funds to acquire or construct and equip a County investment (spec) building along with related infrastructure;

WHEREAS, under the plan of finance, the approximate total costs of the projects (with related infrastructure) were \$14,350,000, allocated as follows: (a) County's Gateway Conference Center: \$6,000,000; (b) County's hazardous material building: \$750,000; (c) County investment (spec) building: \$6,900,000; and (d) additional contingency for these projects: \$700,000;

WHEREAS, the cost to complete the improvements to the County's Gateway Conference Center was approximately \$4,585,432.38, leaving approximately \$1,414,567.62 (without regard to additional contingency) allocated, but unspent;

WHEREAS, the pro rata share of the additional contingency (\$700,000) that would have been allocated to the County's Gateway Conference Center is approximately \$307,692.31 (approximately 43.956% of the total available contingency);

WHERERAS, the County intends to renovate, expand, acquire, design construct, and equip a new or existing County animal shelter (collectively, "2020 Project"), as a "Project" under Section 1 of the 2018 Ordinance and an additional "Ancillary Project" under and according to the Amended and Restated Installment Purchase and Use Agreement between Chester Facilities Corporation and Chester County, South Carolina, dated June 28, 2018 ("ARIPUA"), without incurring any debt or otherwise expanding the financial liability under the County's existing arrangement with the Corporation; and

WHEREAS, subject to the consent of the Corporation and of Assured Guaranty Municipal Corp., as bond insurer of the 2018 Bonds ("Bond Insurer"), the County intends to reallocate not to exceed \$1,722,000.00, representing the unspent portion of funds allocated to the County's Gateway Conference

Center improvements with related additional contingency, to be used to provide funds for the 2020 Project and pay all costs associated with the same;

NOW, THEREFORE, the Chester County Council resolves:

SECTION 1.01. *Financing Documents.* So long as the County does not incur any debt or otherwise expand the financial liability under the County's existing arrangement with the Corporation, the County is authorized to enter and consent to amendments or supplements to or restated (a) base lease and conveyance agreements, (b) installment purchase and use agreements, and (c) other similar documents (collectively, "Financing Documents"), all as may be necessary (a) to ensure the 2020 Project is a "project" as defined under Section 1 of the 2018 Ordinance, (b) to ensure the 2020 Project is an additional "Ancillary Project" as defined under the ARIPUA, and (c) to provide funding for the 2020 Project and all costs associated with the same.

The County Supervisor ("Supervisor"), and designees, are authorized to negotiate and approve the form of the Financing Document on behalf of the County, and the Supervisor and Clerk to County Council ("Clerk") are authorized to execute the amendments or restatements on behalf of the County and deliver the same to the Corporation and the Bond Insurer.

SECTION 1.02. General Authorization. The Supervisor and the Clerk, and their designees, are authorized to execute and deliver whatever documents and take whatever actions, including, for example, certificates, consents, and notices, specifically as related to the Bond Insurer, the Corporation, and the Municipal Securities Rulemaking Board's Electronic Municipal Market Access platform, as are reasonably necessary or desirable to affect this Resolution's intent.

SECTION 1.03. Resolution's Effect. This Resolution shall supplement and, absent express language to the contrary, shall not supplant and shall not otherwise repeal by implication or otherwise, the 2018 Resolution.

SECTION 1.04. Effective Date. This Resolution is immediately affective, and no further authorization is required to execute and deliver all documents necessary or desirable to affect this Resolution's intent. To the extent Section 2 of the 2018 Ordinance is applicable, this Resolution is intended to satisfy those requirements. This Resolution shall be construed liberally to affect the County Council's intent.

Declaration 2020-4

A DECLARATION OF A CONTINUED STATE OF EMERGENCY FOR CHESTER COUNTY

WHEREAS, on March 13, 2020, both the President of the United States and South Carolina Governor Henry McMaster declared that the COVID-19 pandemic in the United States constitutes a national emergency; and

WHEREAS, on March 17, 2020, Chester County Council declared that the COVID-19 pandemic was a threat to Chester County and declared a State of Emergency for fourteen (14) days; and

WHEREAS, on March 30, 2020, Chester County Council initiated further emergency measures, suspending certain Rules of Procedure to ensure the proper function and continuity of County government operations and the uninterrupted performance and provision of emergency, essential, or otherwise mission-critical County government services while simultaneously undertaking additional measures to safeguard the health and safety of County employees, mitigate significant economic impacts and burdens on affected individuals and citizens, and provide regulatory relief to expedite emergency response initiatives; and

WHEREAS, also on March 30, 2020, Chester County Council by emergency ordinance 2020-11 extended the State of Emergency for an additional sixty (60) days based on a determination that COVID-19 posed an actual, ongoing, and evolving public health threat to Chester County; and

WHEREAS, on May 18, 2020, Chester County Council by emergency ordinance 2020-12 extended the State of Emergency for an additional sixty (60) days based on a determination that COVID-19 continues to be a public health threat to Chester County; and

WHEREAS, on July 20, 2020, Chester County Council recognized and extended the State of Emergency for an additional sixty (60) days based on a determination that COVID-19 continues to be a concern to the County; and

WHEREAS, that State of Emergency will expire on September 26, 2020 and out of an abundance of caution for the continued health and improvement of the County citizens and their protection, the County believes that it must continue the State of Emergency for an additional sixty (60) days in order to utilize extraordinary measures and to deploy substantial resources to meet the unprecedented threat posed by COVID-19 and the evolving nature and scope of this public health emergency, and in order to promptly and effectively do this, the County must take any and all necessary and appropriate steps to facilitate a coordinated response to the current and anticipated circumstances.

Pursuant to the authority granted to the Chair of Chester County Council and as Chester County Supervisor, K. Shane Stuart, finds it necessary to look to Chester County Council to declare a State of Emergency under the same provisions and caveats as are outlined in the Emergency Ordinance of May 18, 2020, #2020-12 for an additional sixty days.

NOW THEREFORE, the Chester County Council hereby declares an extended State of Emergency to exist and such extension shall continue for a period of sixty (60) days from the expiration of the prior State of Emergency, unless sooner terminated by act of Chester County Council.

Vice Chairman Smith made a motion to adjourn; seconded by Commissioner Howell. Vote was 5-0 to adjourn.



Re: Rural Fire Vehicle Consideration

Chairman Stuart and Council Members,

Over the past several months, the above referenced Fire Coordinators Office Response vehicle has broken down multiple times. During the Carolina Poly fire, which was a multi-day incident, the vehicle was unable to be used to haul the necessary foam and equipment due to misfiring and stalling. We had to tie up an EMA vehicle to accomplish the tasks which should have been performed by this office. The truck was taken to the shop with bad spark plugs and coils. Two days later, the vehicle again broke down at the scene of a serious motor vehicle accident and was subsequently taken to the county maintenance shop. The maintenance shop diagnosed the problems as a bad head, timing chains, and piston issues. The estimated cost for the above repairs would be \$3500-5000. Due to the truck being over 18 years old and having over 21\$,000 miles, it would be cost-prohibitive to spend money repairing it. We also have a 1995 Chevy S-10 pickup truck with is not suitable for daily use to do condition.

Our office responds to all major fires, car accidents, Hazmat, and fire investigations within the county during the day as well as hauling supplies, performing maintenance on other county equipment, and conducting fire inspections in county businesses. Our response is not limited to Monday through Friday 9-5 as we are on call 24 hours a day, seven days a week, 365 days a year. We also attend multiple classes and training outside the county to keep out staff up to date on training and fire service issues throughout the state. This office has requested replacement vehicles in the past four budget year requests, which were ultimately denied. The county motor pool is a temporary solution, but there are no vehicles there that meet the basic needs of jobs we need to perform. Not having the appropriate vehicles to perform our jobs adequately is seriously hindering the mission of the Chester County Fire Coordinators Office and the Rural Fire Commission.

We are requesting replacement vehicles that can haul supplies, storing investigative and inspections tools, spare equipment for the county fire departments, and the swift water rescue gear we will need. We also need vehicles that are 4-wheel drive, due to the changing terrain within the county and can safely tow the fire safety trailer and any other county assets. Your consideration in this matter is greatly appreciated.

We look forward to working together to be able to properly serve the fire departments and citizens of Chester County in a safe and efficient manner.

Ordinance 2020-13 Rehabilitated Historic Properties

Section 1: Special Tax Assessment Created.

A special tax assessment is created for eligible rehabilitated historic properties for a period of ten (10) years equal to the assessed value of the property at the time of preliminary certification.

Section 2: Purpose.

It is the purpose of this Article to:

(1) Encourage the rehabilitation of historic properties;

(2) Promote economic development and community redevelopment;

(3) Encourage sound community planning; and

(4) Promote the general health, safety, and welfare of the community.

Section 3: Eligible Properties.

(a) Certification. In order to be eligible for the special tax assessment, historic properties must receive preliminary and final certification.

(1) Preliminary certification. To receive preliminary certification a property must meet the following conditions:

a. The property meets the requirements for historic designation as established in this section.

b. The proposed rehabilitation work receives a recommendation of approval from the Historic Preservation Commission (hereinafter "HPC") and is consistent with the rehabilitation standards as set forth in this article. The HPC shall review all improvements associated with the rehabilitation and make a recommendation to the county regarding the project's eligibility.

c. Be a project that commenced by or after August _____, 2020 to the date of the adoption of this ordinance and work was permitted to have begun prior to receiving preliminary certification, or

d. Be a project that commences on or after the date of the adoption of this ordinance.

(2) Final certification. To be eligible for final certification, a property must have met the following conditions:

a. The property has received preliminary certification.

b. The minimum expenditures for rehabilitation as set forth in this article have been incurred and paid.

c. The completed rehabilitation receives a recommendation for approval from the HPC as being consistent with the plans approved by it during preliminary certification.

d. All application fees have been paid in full by the applicant.

e. The property has met all other requirements of this article.

(b) Historic designation. In order to be eligible for the special tax assessment, the property must meet one of the following criteria:

(1) The property must be listed on the National Register of Historic Places either

individually or as a contributing property in a district; or

(2) The property is designated as a historic property by the City Council based upon criteria established by the City Council and the property is at least fifty (50) years old.

(c) Historic Property Criteria. In order to be eligible for the special tax assessment, the property must meet one of the following criteria:

 Any property included in one of the categories below is considered a Historic Property:

a. Listed on the National Register of Historic Places;

b. Determined eligible for the National Register by the South Carolina Department of Archives and History;

c. A contributing property in a National Register Historic District;

d. City of Chester Historic Landmark.

(2) All other properties must demonstrate an:

a. Association with events that have made a significant contribution to the broad patterns of our history;

b. Association with the lives of significant persons in our past; or

c. Embodiment of distinctive characteristics of a type, period, or method of construction; or representation of the work of a master; or possession of high artistic values.

Property owners seeking eligibility under this section must receive a historic property determination by filing an application with Chester County (or City of Chester).

Eligible rehabilitation.

(a) Standards for rehabilitation. To be eligible for the special tax assessment, historic rehabilitations must be conducted according to the following standards:

(1) The historic character of a property shall be retained and preserved. The removal of historic materials or alterations or of features and spaces that characterize each property shall be avoided.

(2) Each property shall be recognized as a physical record of its time, place and use. Changes that create a false sense of historical development shall not be undertaken.

(3) Most properties change over time. Those changes that have acquired historic significance in their own right shall be retained and preserved.

(4) Distinctive features, finishes, and construction techniques or examples of craftsmanship that characterizes a property should be preserved.

(5) Deteriorated historic features shall be repaired rather than replaced. Where the severity of deterioration requires replacement of a distinctive feature, the new should match the old in design, color, texture, and other visual qualities and, where possible, materials. Replacement of missing features shall be substantiated by documentary, physical or pictorial evidence.

(6) Chemical or physical treatments, such as sandblasting, that causes damage to historic materials shall not be used. The surface cleaning of structures, if appropriate, shall be undertaken using the gentlest means possible.

(7) New additions, exterior alterations, or related new construction shall not destroy historic materials that characterize the property. The new work shall be differentiated from the old and shall be compatible with the massing, size, scale and architectural features to protect the historic integrity of the historic property and its environment.

(8) New additions and adjacent new construction shall be undertaken in such a manner that, if removed in the future, the essential form and integrity of the historic property and its environment would be unimpaired.

(b) Work to be reviewed. The following work will be reviewed according to the standards set forth above:

(1) Repairs to the exterior of the designated building.

(2) Alterations to the exterior of the designated building.

(3) New construction on the property on which the building is located, including site work.

(4) Alterations to interior primary public spaces, as defined by the reviewing authority.

(5) Any remaining work where the expenditures for such work are being used to satisfy

the minimum expenditures for rehabilitation, including, but not limited to, alterations made to mechanical, plumbing and electrical systems.

(c) Minimum expenditures for rehabilitation. To be eligible for the special property tax assessment, the owner or the owner's estate must meet the minimum expenditures for rehabilitation:

(1) The minimum investment shall be twenty percent (20%) of the fair market value of the building which is to be rehabilitated.

(2) Fair market value means the appraised value as certified to the county by a real estate appraiser licensed by the State of South Carolina, the sales price as delineated in a bona fide contract of sale within twelve months of the time it is submitted, or the most recent appraised value published by the Chester County Tax Assessor.

(d) Expenditures for rehabilitation means the actual cost of rehabilitation relating to one or more of the following:

(1) Improvements located on or within the historic building as designated.

(2) Improvements outside of but directly attached to the historic building which are necessary to make the building fully useable (such as vertical circulation) but shall not

include rentable/habitable floor space attributable to new construction.

(3) Architectural and engineering services attributable to the design of the improvements.

(4) Costs necessary to maintain the historic character or integrity of the building.

(e) Scope. The special tax assessment may apply to the following:

- (1) Structure(s) rehabilitated;
- (2) Real property on which the building is located.

(f) Time limits. If the project is not complete after two (2) years, but the minimum expenditures for rehabilitation have been incurred, the property continues to receive the special assessment until the project is completed.

Section 4: Process.

(a) Fee required. There is a fee required for the review of rehabilitation work during the final certification process. Final certification of the property will not be given until the fee has been paid in full by the applicant. Fees shall be made payable to Chester County. The amount of the fee shall be as follows:

(1) For owner-occupied, non-income producing properties, the fee shall be one hundred and fifty dollars (\$150.00).

(2) For income-producing or non-owner occupied properties, the fee shall be three hundred dollars (\$300.00).

(b) Plan required. Owners of property seeking approval of rehabilitation work must submit a completed rehabilitation of historic property application with supporting documentation to the Code Enforcement Officer prior to beginning work. Rehabilitation work conducted prior to approval of the application is done so at the risk of the property owner.

(c) Preliminary certification. Upon receipt of the completed application, the Code Enforcement Officer shall submit the plan to the HPC for a recommendation as to whether the project is consistent with the standards for rehabilitation. Upon receipt of the HPC's recommendation, the Code Enforcement Officer shall notify the owner in writing. Upon receipt of this determination, the property owner may:

(1) If the application is approved, begin rehabilitation;

(2) If the application is not approved, he/she may revise such application in accordance with comments provided by the HPC.

(d) Substantive changes. Once preliminary certification is granted to an application, substantive changes must be approved in writing by the Code Enforcement Officer. Any substantive changes made to the property during rehabilitation that are not approved by Code Enforcement Officer, upon review and recommendation of the HPC, are conducted at the risk of the property owner and may disqualify the project from eligibility during the final certification process.

(e) Final certification. Upon completion of the project, the property must receive final certification in order to be eligible for the special assessment. The HPC shall inspect completed projects to determine if the work is consistent with the approval recommended by the HPC and granted by it during preliminary certification. The review process for final certification shall be established by the HPC and may include a physical inspection of the property. The HPC shall notify the applicant in writing of its recommendation. If the applicant wishes to appeal the HPC recommendation, the appeal must follow the reviewing authority's appeals process. The Code Enforcement Officer may grant final certification only if the following conditions have been met:

(1) The completed work meets the standards for rehabilitation as established in this article;

(2) Verification is made that the minimum expenditures have been have been incurred in accordance with the provisions of this article; and

(3) Any fee(s) shall be paid in full.

Upon receiving final certification, the property will be assessed for the remainder of the special assessment period on the fair market value of the property at the time the preliminary certification was made or the final certification was made, whichever occurred earlier.

(f) Additional work. For the remainder of the special assessment period after final certification, the property owner shall notify the Code Enforcement Officer of any additional work, other than ordinary maintenance, prior to the work beginning. The HPC shall review the work and make a recommendation to the Code Enforcement Officer whether the overall project is consistent with the standards for rehabilitation. The Code Enforcement Officer shall notify the property owner in writing if the overall project is consistent with the standards for rehabilitation. If the additional work is found to be inconsistent by the HPC, the Code Enforcement Officer shall notify the owner in writing within thirty (30) days of its decision to rescind approval. The property owner may withdraw his/her request and cancel or revise the proposed additional work.

(g) Notification. Upon final certification of a rehabilitated historic property, the Chester County Assessor, Auditor, and Treasurer shall be notified by the Code Enforcement Officer that such property has been duly certified and is eligible for the special tax assessment.

(h) Application. Once the final certification has been granted, the owner of the property shall make application to the Chester County Auditor for the special assessment provided for herein. The special assessment shall remain in effect for the length of the special assessment period, unless the property shall become decertified under the provisions of this section.

(i) Date effective. If an application for preliminary or final certification is filed by May first or the preliminary or final certification is approved by August first, the special assessment authorized herein is effective for that year. Otherwise, it is effective beginning with the following year. The special assessment only begins in the current or future tax years as provided for in this section. The special assessment period shall not exceed twenty (20) years in length, and in no instance may the special assessment be applied retroactively.

(j) Previously certified properties. A property certified to receive the special property tax assessment under the existing law continues to receive the special assessment in effect at the time certification was made.

(k) Decertification. Once the property has received final certification and assessed as rehabilitated historic property, it remains so certified and must be granted the special assessment until the property becomes disqualified by any one of the following:

(1) Written notice from the owner to the Chester County Auditor requesting removal of the special assessment;

(2) Removal of the historic designation by the City Council based upon noncompliance of the criteria established in Section 3 (c)

(3) Rescission of the approval of rehabilitation by the county, at the recommendation of the HPC, because of alterations or renovation by the owner or the owner's estate which causes the property to no longer possess the qualities and features which made it eligible for final certification. Notification of any change affecting eligibility must be given immediately to the Chester County Assessor, Auditor, and Treasurer.



A Presentation to Chester County Council regarding a Special Tax Assessment for Rehabilitated Historic Properties by The City of Chester

State Law

- SC Code of Laws §4-9-195 and §5-21-140
 - Grant of special property tax assessments to "rehabilitated historic property" or "low and moderate income rental property".
- The Bailey Bill authorizes local governments to offer a special property tax assessment for rehabilitated historic buildings for up to 20 years.

General Purpose

- Encourage the rehabilitation of historic properties

Facts & Features

Features

- Special Tax Assessment for up to 20 years
- Historically Significant Properties Federal, State, or Local designations

Eligible Improvements

City of Chester's Bailey Bill Ordinance

- Simplified eligibility: designated Historic Buildings and buildings within the historic districts
- 2. Assessment: 10 years
- Minimum Investment Required: 20% fair market value, must be met within 2 years
- Historic Preservation Commission and Code Enforcement Officer are the designated reviewing authorities.
- 5. Improvement Plan must be reviewed and approved by the HPC.
