1. Approval of CCTC Meeting Minutes of January 17, 2012
CCTC Member Holcombe made the Motion to approve the CCTC Minutes of January 17, 2012, 2nd by CCTC Member Jordan, CCTC vote was unanimous.
2. Request for reimbursement for channel post - \$1,161.00 to Road Dept.
CCTC Member Branham made the Motion to approve reimbursement for Channel post in the amount of \$1,161.00 from C-Funds to the Road Dept., 2nd by CCTC Member Guy, CCTC vote was unanimous.
3. Request for reimbursement for sign material - \$4,117.35 to Recycling Dept.
CCTC Member Branham made the Motion to approve reimbursement for Channel post in the amount of \$4,117.35 from C-Funds to the Recycling Dept.,

2nd by CCTC Member Oliphant, CCTC vote was unanimous.

4. Recommendation of bids on 2012 Reclamation project
- Mr. L.B. Cannon/Dennis Corporation** stated that the Bids had been received and Boggs Paving was the low bidder on the following roads:

CCTC Member Jordan made the Motion to award the bid in the amount of \$575,237.90 to Boggs Paving, 2nd by CCTC Member Branham, CCTC vote was unanimous.

5. Approval of 2012 C-Fund 25% Roadway Match – **Jeremiah Bradley/SCDOT**
- Nell Ramsey Rd. - \$32,490.73
- Purity Rd. - \$145,978.12
- Sunset Dr. - \$90,820.55
- Bobby Butler Rd. - \$69,348.24
- Total: **\$323,637.64**

Mr. Bradley stated there were the four roads that the SCDOT Maintenance Dept. recommended for the 25% Match and he suggested that a 15% Contingency be added because of the fuel prices. **CCTC Member Lucas** had a lengthy conversation with Mr. Bradley about Main St. in Great Falls. **Mr. Bradley** told **Mr. Lucas** that he had no control over which roads were selected and that he would need to contact the Commissioner.

CCTC Member Branham made the Motion to approval the 2012 C Fund 25% Roadway Match in the amount of \$323,637.64, 2nd by CCTC Member Guy, CCTC vote was 5-1 with CCTC Member Lucas voting against the motion.

CCTC Member Holcombe made a Motion to adjourn the Chester County Transportation Committee Meeting, 2nd by CCTC Member Lucas, CCTC vote was unanimous.
