POSITION SUMMARY:

Responsible for operating heavy construction equipment and performing minor maintenance on such equipment in the performance of field construction, maintenance and repair activities.

ESSENTIAL FUNCTIONS:

This class specification lists the major duties and requirements of the job and is not all-inclusive. Incumbent(s) may be expected to perform job-related duties other than those contained in this document and may be required to have specific job-related knowledge and skills.

- Performs an operational and safety check of equipment before use; checks fuel and fluid levels, air pressures, hydraulic systems and lubrication points; performs lubrication of essential parts.
- Performs minor adjustments and preventive maintenance and reports the need for major maintenance or repairs.
- Operates a variety of heavy construction equipment such as motor graders, backhoes, scrapers and dump trucks.
- Operates rollers, loaders and other medium weight equipment as required by the assignment.
- Ensures that tools, equipment, safety devices and materials required for the job are loaded prior to moving to the job site.
- Checks job sites for potential hazards; ensures that appropriate traffic control and warning devices are properly placed and safety equipment is worn.
- Secures equipment upon completion of the work.
- Maintains basic logs and records related to work performed.
- Contributes to the efficiency and effectiveness of the unit's service to its customers by offering suggestions and directing or participating as an active member of a work team.
- Serves as a member of a crew and performs heavy physical labor as required.
- Observes safe work methods and utilizes safety equipment related to the work.
- Uses and performs minor maintenance on hand tools related to the work.
- Demonstrates courteous and cooperative behavior when interacting with the public and staff;
 acts in a manner that promotes a harmonious and effective workplace environment.

- Capabilities, operational characteristics, adjustments and preventive maintenance of a variety of trucks and related vehicles.
- Public Works maintenance and repair methods and techniques related to the area of assignment.
- Use and maintenance of power tools related to the work.
- Traffic laws and ordinances applicable to equipment operation.
- Safety principles, practices and equipment related to the work.
- Record keeping practices.
- Techniques for dealing with a variety of individuals from various ethnic and social backgrounds.

Skill in:

- Operating a variety of construction equipment skillfully and safely.
- Driving a variety of vehicles skillfully and safely.
- Adjusting and performing preventive maintenance on the equipment to which assigned.
- Recognizing potentially hazardous situations on the job site and taking appropriate action.
- Safely using and maintaining hand and power tools related to the work.
- Reading and understanding a variety of plans and maps.
- Producing and maintaining accurate records of work performed.
- Working without close supervision in standard work situations.
- Understanding and following written and oral instructions
- Working successfully with a variety of individuals from various socio-economic, ethnic and cultural backgrounds.
