Legislation pending in the South Carolina General Assembly; as our members strongly believe this Legislation will seriously impede the ability of cities and counties to manage Solid Waste and Recycling programs, and will have far reaching unintended circumstances that have not been fully vetted with South Carolina Counties Council Member Lucas made the Motion to approve the Resolution urging South Carolina General Assembly Members to oppose House Bill 3290 and Senate Bill 203 and expressing the South Carolina Solid Waste and Recycling Professionals Association opposition to this Special Interest Legislation pending in the South Carolina General Assembly; as our members strongly believe this Legislation will seriously impede the ability of cities and counties to manage Solid Waste and Recycling programs, and will have far reaching unintended circumstances that have not been fully vetted with South Carolina Counties, 2nd by Vice Chairman Branham, Council Member Lucas then asked if the Bill was trying to tell counties that they could not direct where their Solid Waste goes.
