VI. Ordinances & Resolutions

2nd Reading of An Ordinance to Amend the Enabling Act for the Chester County Medical Responder Advisory Council

Council Member Lucas made a Motion to approve 2nd Reading of an Ordinance to Amend the Enabling Act for the Chester County Medical Responder Advisory Council, 2nd by Council Member Holcombe, Council vote was unanimous.

VII. New Business

1. Changes in Organizational Chart

HR Director Cindy Goettsch & Sheriff Underwood came before Council to request changes in the Organizational Chart. Mrs. Goettsch stated that in the Sheriff's Dept. three positions were eliminated, the chart should have shown four positions in Animal Control – not three – and NCIC should have been added to 911. Sheriff Underwood stated the Detention Center stayed the same but salaries were adjusted to bring everyone in line and Line Officers pay was increased. Sheriff Underwood also stated if an officer graduating from the Academy left before a year was up, he/she would be required to pay back the tuition. Mrs. Goettsch also said some ranks were eliminated. Council Member Lucas asked if there any additional people and Mrs. Goettsch replied "no". Vice Chairman Branham asked for an updated version of the chart and Mrs. Goettsch replied she would get Council a copy. Council Member Oliphant made a Motion to approve the Organization Chart with the two noted amendments (4 officers in Animal Control and NCIC added to 911, 2nd by Council Member Guy, Council vote was unanimous.

Council returned from Executive Session and Council Member Guy made a Motion to Return to Regular Session, 2nd by Council Member Holcombe, Council vote was unanimous. Council Member Oliphant had to leave Executive Session for a prior commitment.

Chairman Roddey stated that the first legal matter discussed in Executive Session was taken as information only.

Chairman Roddey then stated that a 2nd contractual matter was discussed in Executive Session regarding the old health department in Great Falls. Council Member Lucas made a Motion to lease this building to the Chester Regional Hospital for \$500 a month and Chester Regional would take care of all expenses, 2nd by Vice Chairman Branham, Council vote was unanimous.

Chairman Roddey stated that last item discussed in Executive Session was House Bill 3290 regarding Solid Waste Ordinances and was taken as information only.
