Call to Order Old Business

1. Approval of CCTC Meeting Minutes of July 6, 2010

Council Member Branham motion to approve CCTC Meeting Minutes of July 6, 2010, 2nd by Council Member Lucas, CCTC vote was unanimous.

2. Chester Research & Development Park

Mr. Deepal Eliatamby stated the park was only good with amenities that would provide opportunities for prospects. He went on to say it was important the park looked like a research development park. Mr. Eliatamby stated the first thing was to install water lines along with the landscaping and signage. Mr. Roddey stated he had spoken with Catawba Regional and would like to pursue a grant to pay for the road and landscaping. Council Member Branham motioned to pursue the road for the Industrial Park to come out of the C-Funds. 2nd by Council Member Lucas. CCTC vote was unanimous.

Eddie Murphy stated everything FEMA has requested the County to do has been done, waiting on them to send back information.

LB Cannon stated the road improvement project adjacent to Murdock had been put on hold due to obtaining wetland permits.

7. Update on Point Drive

LB Cannon stated along with Point Drive they had also taken in Goblet, Crown Court into the County road system. The four property owners do have a 30 ft easement dedicated for a roadway improvement.

8. Update on "One Way in and One Way Out" Roads
LB Cannon stated the plans were ready to go, waiting on estimated cost.
